Testing and trialing will be delayed when lightning or extremely heavy rain is affecting the scheduled event, and participants will be advised to return to their quarters or move to the Bunkhouse until the storm passes.

In the event of a wide area electrical failure (the ranch and nearby towns) predicted to last several hours, participants will be asked to check in at the Trial Headquarters to be advised by the emergency coordinator about optional meals that can be made available at the ranch with help from all on site. Should a natural disaster event occur requiring evacuation of the property, participants will be asked to check in at the Trial Headquarters to be advised by the emergency coordinator of the details of the evacuation plan as provided by the Torrance County officials.

## ELIGIBILITY

All dogs nine months of age or older that are registered with the American Kennel Club and classified as Herding Dogs under Chapter 2 of the Dog Show Rules are eligible to participate in herding tests and trials. Dogs classified as Herding Dogs under Chapter 2 of the Dog Show Rules that have been granted an Indefinite Listing Privilege (ILP) may participate in tests and trials.

No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any test/trial.

Bitches in season shall be eligible and will run at the end of the class in tests, and in catalog order as listed in the class in trials.

A dog must be entered in the name of the person who actually owned it at the time entries for the herding test or trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any herding test or Trial for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his or her name. State on entry form whether transfer application has been mailed to AKC. (for complete rule refer to Chap. 14, Sect 3 of "Rules Applying to Registration and Dog Shows")

## AGREEMENT

I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" and the "Rules for Herding Tests and Trials" have been made available to me (us) and that I (we) agree that the club holding this Herding Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Herding Test or Trial and of the opportunity to have the dog tested or judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its' members, directors, governors, officers, agents, superintendents or show secretary and owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Herding Test or Trial premises or grounds or near any entrance thereto, and I(we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in the Herding Test or Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (we) will pay for any livestock injuries or replacement value in the event of death of any livestock by my (our) dog. In case of any injury to any stock caused by the dog entered, I (we) will assume total responsibility for any damage I (we) agree to pay the full market value of the injured animal in case of serious injury, or the veterinarian bill if the injury is slight.

**SAFETY, BEHAVIOR, LIABILITY:** Members of the New Mexico Herding Dog Association (NMHDA) and Free To Be Ranch and their agents assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or their dogs, or property, and further assume no responsibility for injury to children or guests.

NMHDA may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and no one shall have any claim or recourse against NMHDA, Free To Be Ranch, or any official thereof.

Safety of the dogs is our primary concern. By entering this event, exhibitors acknowledge that they are familiar with the rules and regulations of the sport.

All dogs must be on a leash at all times except when on course. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs, guests and/or children. Those engaging in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the site. In such cases, there will be no refund of fees paid. In consideration of others, you will be expected to clean up after yourself and your dogs at the event site and at your motel. Failure to do so may be cause for dismissal.

**Refunds:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entry fees will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, violent acts of nature, public emergency, or any other cause beyond the control of the Trial Committee. All rules and regulations governing the use of the Free To Be Ranch facility and all regulations and decisions of the Trial Committee will be strictly enforced, including and not limited to the recording information of this premium list.

Faxed, telephoned, unsigned, or incomplete entries cannot be accepted. Entries submitted that are not on the provided official AKC entry forms provided in this premium (or reasonably recognized and accepted AKC similar forms) will not be accepted. All AKC entry forms shall contain the agreement and rules as part of the entry form. No entry shall be made and no entry shall be accepted which specifies any conditions to its acceptance.

Multiple entries per single envelope will be accepted. Multiple entries could include a combination of one dog entered in the six trials, or multiple dogs entered in any combination of the six trials.
